About your day

We will meet you on the arboretum terrace when you arrive, where you will have time to use the facilities, before we head off to the forest school site for your chosen programme. Once at the site we will stay there for the day unless you have chosen a programme that includes the self-guided visit to the arboretum.

We will explore your chosen subject with a variety of activities that can be adapted to, to meet the needs of your group.

Participants will enjoy these outdoor activities in a relaxed and spontaneous manner through a variety of focused and learner-led activities. This allows the participant to develop and learn in a way that is beneficial to their development of self-esteem, confidence and respect and provide opportunities for an inquisitive and positive

Aims

- To learn about the subject matter
- To gain practical outdoor skills, try new activities and initiate ideas
- To operate independently within the outdoor environment
- Safety: To show awareness of the boundaries set and behaviour expectations for the site and activities by following instructions.
- For the forest school leader and accompanying adults to show adaptability and versatility during the session
- Health: To appreciate a need for hygiene in the outdoors
- To engage with nature and interact with the outdoor environment and approach outdoor learning experiences positively
- To build self-esteem and self confidence
- To promote team building and trust.
- To learn to care for one self, others and have an understanding of the natural environment
- To increase communications skills and create listening opportunities
- To promote opportunities for exploration and discovery.

A list of the activities and the structure of the day will be attached separately, along with a copy of the quote and the terms and conditions.

The programme is bespoke to your group, should you wish to make changes or add an activity please do not hesitate to contact us to discuss the options.

You are welcome to visit the arboretum prior to your visit with a colleague to carry out your own risk assessments on a day it is open to the public (Please check the website for opening hours -www.bodenhamarboretum.co.uk)

When you arrive go to the reception desk and mention that you are visiting to carry out a risk assessment for a school trip to obtain an entrance sticker.

Important Information

- Activities are led by a level 3 forest school leader with an enhanced DBS and first aid qualified.
- School staff are responsible for the administering of first aid, medication, behaviour, welfare of their pupils at all times.
- Students will need all day supervision and each group will need a supervising adult to support the activities. We suggest a ratio of 1:6 for groups of 30 for key stages 1 and over and 1:4 for preschool
- For parties over 15 or more it may be necessary to split them into groups for certain activities. All groups should have a first aider present and a first aid kit. If the group is to be split in to two you will require two first aiders with first aid kits.
- All children will need suitable clothing i.e. wellies; layers of warm activity clothes, hats, warm/layers of socks, scarves gloves/ sun protection cream waterproof coat and trousers.
- If visiting for the whole day, all staff and pupils should bring a packed lunch and adequate drinks for the day. All rubbish arising should be taken back to the school with you.
- Please note that unless entry to the arboretum has been included in the quote you only have access to the forest school site, not the arboretum, you do not need to pay entry to the Arboretum to attend forest school.
- Prior to your visit please make us aware of any students with additional requirements or special needs so if possible we can make all necessary arrangements.

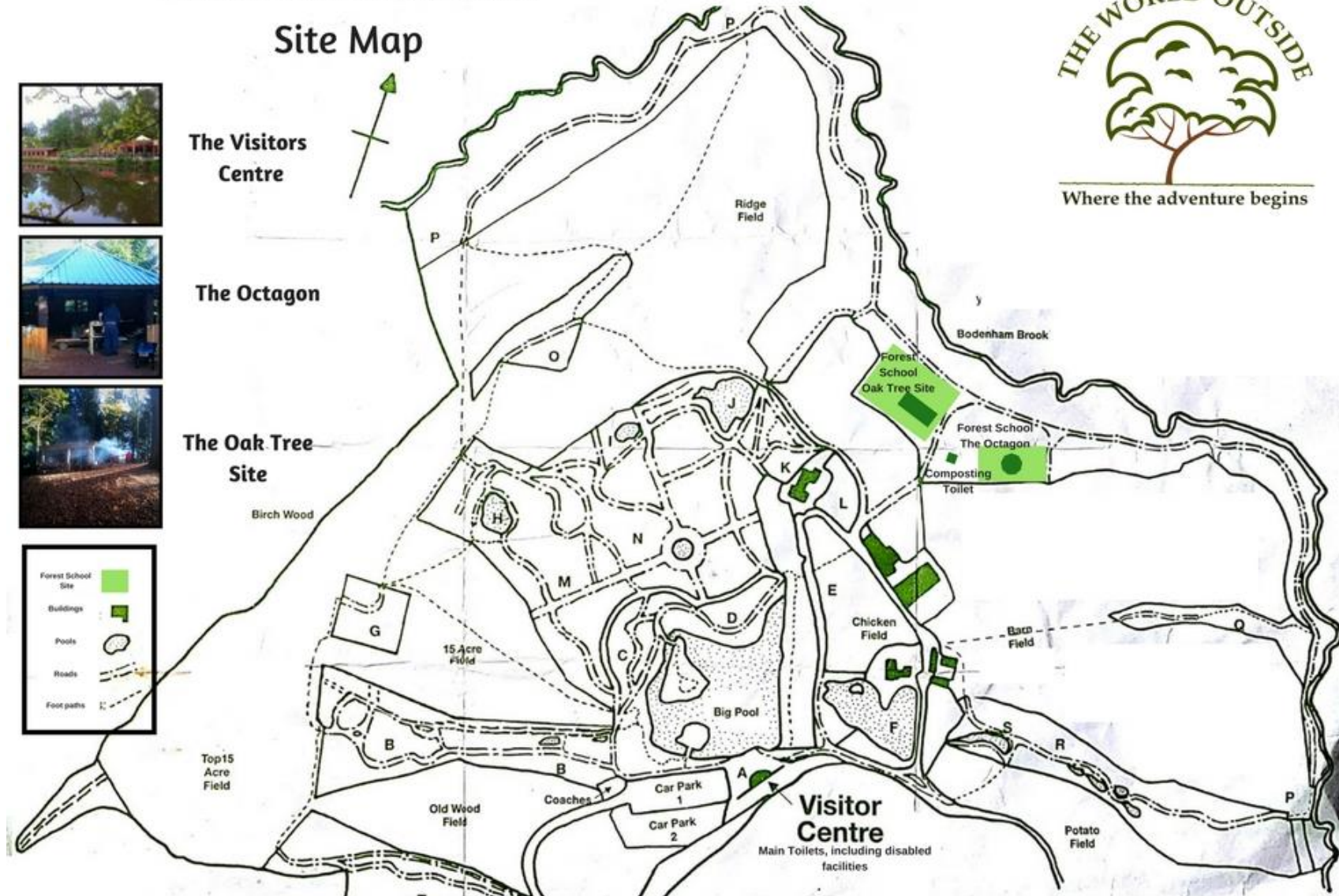

Your child is coming to visit us at Bodenham Arboretum for a Forest School experience.

Your child will have access to a shelter,
but they will primarily be outside for most of the day – ‘Whatever the weather’

To ensure that your child has a fabulous time please make sure of the following:

- Your child has layers of warm activity clothes – long sleeves and trousers
 - Your child brings an extra jumper
- Your child has a waterproof coat (and if possible waterproof trousers)

If your child does not have waterproofs please inform the school or trip organiser and send them with at least one complete set of clean dry clothes .

- Sturdy Shoes or Wellingtons – either trainers or preferably walking boots or wellies
 - A packed lunch – unless they have school lunches
 - (If they have school lunches please order a packed lunch
 - with the school on the day of the trip if this is applicable)
 - Plenty to drink
- If it is going to be cold please send a hat, scarf and gloves
- If it is going to be warm please ensure you have applied all day sun protection cream and if you have it insect repellent and please send them with a hat
- All the above should be in a ruck sack/bag that can be zipped shut and that they can carry easily by themselves

Forest School offers learners the opportunity to take supported risk as appropriate to the environment and themselves. Forest School is run by qualified Forest school practitioners who continuously maintain and develop their professional practice and are trained in dynamic risk assessment and they constantly assess the risk/benefit of each activity throughout the session.

The Forest school leader expects teachers/parents to bring medical information and medication and ensure that this is held with the adult in charge of the child at all times. The Forest school leader requests that any medical conditions are brought to their attention before the start of the session. Risk assessment to be read in conjunction with Site Risk assessment, individual activity and specific hazard risk assessments and the Policies and Procedures. Available on request

Due to the nature of the site and the activities, this risk assessment will be evaluated throughout the year and through the course of the visit and adjustments made as and when necessary to adapt to the situation and group

N.B All children and staff should be dressed appropriately in activity clothes with sturdy shoes/ boots, wellies if wet as the site can get very muddy. For Forest School long sleeves and trousers are essential. Everyone should bring waterproof clothing, a change of clothes and wear activity clothes. If staying over lunch time bring a packed lunch and a drink.

Group leaders, you are encouraged to visit the Arboretum, with a colleague to carry out your own risk assessment prior to your visit.

Terms and Conditions

For our forest school activities, we require a minimum of 2 staff or responsible adults per session. Our child-to-adult ratios are as follows:

- Ages 5 and over: 1 adult for every 6 children
- Ages 3 to 5: 1 adult for every 4 children
- Under 2 years: 1 adult for every 3 children

Terms and Conditions

Please inform the Forest School Leader of any significant needs (medical, physical, allergies, learning or physical disabilities, dietary preferences etc.) of the children when booking.

Staff must have any necessary medications (asthma inhalers, epi pens, healthcare plans, etc.) for their pupils on site.

1. Children cannot participate if the appropriate information or necessary medications are not available on site.
2. School/group staff are responsible for first aid, medication administration, and overall pupil welfare.
3. Each group must have a qualified first aider and a first aid kit. If the group splits, each subgroup needs its own first aider and kit.
4. For groups of 15 or more, splitting into smaller groups for certain activities may be necessary.
5. Children should wear suitable clothing (wellies, warm clothes, hats, gloves, sun protection, waterproofs) and bring a change of clothes and an extra jumper.
6. If visiting for the whole day, bring a packed lunch and drinks. The arboretum restaurant may not be open. All rubbish should be taken back with you.
7. This quote is valid for 2 months from the date of issue.
8. The minimum charge for forest school is £220.00, unless stated otherwise. Entry to the arboretum is not included unless specified in the quote.
9. Payment is via BACs transfer only. Cheques are not accepted. A £25 fee applies for cheque payments.
10. No deposit required. Payment due within 21 days of invoice. Late payments incur a £45 surcharge and 10% interest above the Bank of England's base rate. Unpaid invoices accrue an additional £40 weekly.
11. Invoices may be issued in advance. Please provide an email address for the finance department.
12. In case of cancellation beyond our control within four weeks of the visit, payment is still due, and an alternative date will be arranged.
13. Cancellation policy:
14. Over 1 month's notice: No charge
15. 1 month to 2 weeks' notice: 50% of booking charge

Less than 2 weeks' notice: Full charge

Please note, attendance at Forest School does not require arboretum entry, and Forest School attendance does not include arboretum access.
